### UPDATES ON TRANSPORTATION PROGRAM

a) 2010 BUS

The 2010 Ford bus is at the CARS repair shop. Inspection by Wisconsin DOT shows inoperative lights and reflectors. Motion by Black to pursue quotes for replacing the 2010 Ford bus by utilizing the Trust Fund or grants, second by Sponable. All present voting (AYE). Motion carried.

#### b) DOT VEHICLE INSPECTIONS

The 2010 Ford bus, the 2021 Ford bus, and the 2010 Chrysler van were inspected by the Wisconsin DOT. Motion by Black to evaluate the safety of the Chrysler van and pursue its use for medical transport, second by Sommer. All present voting (AYE). Motion carried.

### c) HIRING ADDITIONAL BUS/VAN DRIVERS

Motion by Sommer to advertise for an additional bus/van driver as a back-up at a rate of pay of \$13.60/hr with no daily stipend of \$30/day, second by Sponable. All present voting (AYE). Motion carried.
