#### PUBLIC COMMENT

## UPDATE ON THE BROADBAND PROJECT #1 (MARK DODGE)

Mark Dodge brought a monthly publication his company shares with another county on the progress of the project they are working on for the county. The publication has information on the project, product, timeline, information on their university and what it offers, sales representatives and contact information, tower status and completion timelines. He told the committee this is what he will be offering to Forest County as well.

He went through the current project and where they are on getting it accomplished. Lukas asked for a copy of the extension agreement with the PSC on the project. Dodge showed the application for the extension and told the committee it will be shared when it comes through. He also told the committee all of this is available to view on the PSC website.

Brad Bessert asked if the monthly update could be sent out. It was suggested to upload the link to the county website.

DISCUSSION ON BROADBAND PROJECT #2 AGREEMENT AND SIGNING; POSSIBLE ACTION The agreement has been signed and is in the works. It was asked if the progress of this project would also been done in a publication, but separated from the first project to keep people from getting the two confused.
