#### ADVISE COMMITTEE OF ATV PATROL REIMBURSEMENT

Chief Deputy Walrath advised the committee that the Sheriff's Office received the 2022 ATV Enforcement Patrol Reimbursement in the amount of \$42,765.94 from the Wisconsin DNR.

#### ADVISE COMMITTEE OF SNOWMOBILE PATROL REIMBURSEMENT

Chief Deputy Walrath advised the committee that the Sheriff's Office received the 2022 Snowmobile Enforcement Patrol Reimbursement in the amount of \$13,789.68 from the Wisconsin DNR.

#### DISCUSSION ON COMMUNITY EVENT POLICIES FOR EVENTS

Sheriff Skallerud advised the committee that the matter is being looked into and he will request County Board input and requests the matter be handled by a resolution from the County Board. Skallerud stated he will work on some type of policy for the resolution.

#### BUDGET UPDATES

Sheriff Skallerud advised the committee that the Sokaogon Chippewa made a donation to the Sheriff's Office in the amount of \$11,500 to purchase surveillance cameras.

#### APPROVE TRAINING/TRAVEL REQUISITIONS FOR SGTS DOANE & KELLY

Chief Deputy requested two travel requisitions be approved for Sgt's Kelly and Doane to attend training. The class to be attended is Field Training Officer that will allow them to train newly hired patrol deputies. Motion by Campbell to approve the requisitions, seconded by Tallier. All present voting (AYE). Motion carried.
