- a. Jeannie agrees that having private drives named will help for better location of residences for emergency services and it will even help her office as they sometimes have difficulty finding addresses.
- b. Job Description Update: Statezny presents job description with proposed changes. Departments were asked to update job descriptions for the Carlson-Dettmann wage study. Black expresses that the Emergency Gov't and 911 committee should be listed on the description. Gretzinger would like to add that the director will also serve on the Broadband Committee. Lukas and Gretzinger agree that a Highschool Diploma or equivalent and 18 years or older should be added. Gretzinger recommends that Statezny reach out to the Sheriff to see if he may have anything to add to description. Motion by Black, second by Lukas to approve Job Description along with any additions the Sheriff may have and send to and Clerk as requested. All present voting (AYE). Motion carried.
- c. Safety Gear (uniform/boot allowance): Statezny explains the position needs safety gear such as boots and safety jacket etc., would like to know how/what account to order from. Statezny questions if it should be a reimbursable cost allowance or if it comes out of a specific line item. Statezny expresses she would like to get a pair of boots and a Safety jacket to have in the Truck ready. The committee agrees that the equipment should be ordered to ensure the job being done properly and safely. Lukas questions if there is a miscellaneous line item in her budget.

Motion by Black, second by Lukas to approve Statezny to order boots and safety gear from the budget. All present voting (AYE). Motion carried.
