**CALL TO ORDER**

Nora Matuszewski called the meeting to order at 9:00 a.m.

Motion by Mayer seconded by Mullaney to approve agenda. All present voting AYE. Motion carried.

**APPROVE MINUTES OF THE AUGUST 9, 2022 FALL PRIMARY ELECTION BOARD OF CANVASS**

Motion by Mayer to amend the minutes of the August 9, 2022 Fall Primary Election Board of Canvass to change the total number of election day registrations for the Town of Argonne from six to five, and to change the total number of machine ballots for the City of Crandon from eighty-seven to eighty-six, seconded by Mullaney. All present voting AYE. Motion carried.

**CONDUCT CANVASS OF THE NOVEMBER 8, 2022 GENERAL ELECTION**

**Town of Alvin-Ward 1 –**

Total number of voters ninety-seven (97). No outstanding provisional ballots. Three (3) absentee ballots. Nine (9) EDRs. Fifty-two (52) paper ballots, forty-five (45) machine ballots. Voting unit number and memory device serial number missing from inspector's statement. Number of last vote on the poll list missing from tally sheets. Two voters on page #21 of the poll book have signatures but no voter number. Voter #52 and #53 on the supplemental were not EDRs, they voted in person, changing the total number of EDRs from eleven to nine.

**Town of Argonne-Wards 1-2 –**

Total number of voters two hundred fifty-eight (258). No outstanding provisional ballots. Twenty five (25) absentee ballots. Twelve (12) EDRs. Thirty-eight (38) paper ballots, two hundred twenty (220) machine ballots. Inspector's statement is missing total number of ballots cast.

**Town of Armstrong Creek-Ward 1 –**

Total number of voters two hundred twenty-eight (228). No outstanding provisional ballots. Twenty-four (24) absentee ballots. Sixteen (16) EDRs. One hundred fifty-three (153) paper ballots, seventy-five (75) machine ballots. Total number of EDRs and number of hand-count paper ballots missing from inspector's statement.

### **Town of Blackwell – Ward 1 -**

Total number of voters fifty-six (56). No outstanding provisional ballots.

Eight (8) absentee ballots. Eight (8) EDRs. Eight (8) paper ballots, forty-eight (48) machine ballots.

Total number of voters fifty-one (51). No outstanding provisional ballots.

Three (3) absentee ballots. Five (5) EDRs. Twelve (12) paper ballots, thirty-eight (38) machine ballots.

Absentees were not numbered on absentee ballot log. From incident log: “seal#0326148 broke on printer box tabulator said error while printing vote but vote was cast”, “when we counted up votes we were one short on machine”

### **Town of Crandon-Wards 1-2 –**

Total number of voters two hundred eighty-seven (287). No outstanding provisional ballots.

Twenty-one (21) absentee ballots. Twenty-five (25) EDRs. Seventy-three (73) paper ballots, two hundred fourteen (214) machine ballots.

Last voter number on the poll book and inspector’s statement say 285, actual 287.

From incident log: “after voting started, system completely shut down during a voter voting.

Appeared power cord had been disconnected at some point after pre lat and was running on battery that became depleted.”

Voter #22 on page 10, no signature. Page 20, voter with no number. Voter #210 on page 39, no signature. Voter#147 on page 39 signed the poll book, but was an actual EDR and should have signed the supplemental.

Called in one scattering vote for County Clerk of Circuit Court on election night, vote is not noted on tally sheet.

### **Town of Freedom-Ward 1 –**

Total number of voters two hundred thirty-eight (238). No outstanding provisional ballots.

Forty-two (42) absentee ballots. Nineteen (19) EDRs. One hundred two (102) paper ballots, one hundred thirty-six (136) machine ballots.

Voter on page #22, no voter number, voter had an address change and signed both the poll book and supplemental. Voter number was issued on the supplemental.

**Town of Hiles-Ward 1 –**

Total number of voters two hundred twenty-nine (229). No outstanding provisional ballots.

Sixty-three (63) absentee ballots. Sixteen (16) EDRs. One hundred forty-three (143) paper ballots, Eighty-six (86) machine ballots.

Inspector's statement states 17 total number of EDRs, actual is 16. Voter#A113 on the supplemental was not an EDR, they registered and voted in office on October 28<sup>th</sup>.

**Town of Laona-Wards 1-4 –**

Total number of voters five hundred fifty-two (552). One (1) provisional ballot.

One hundred five (105) absentee ballots. Thirty-nine (39) EDRs. Two hundred eighty-seven (287) paper ballots, two hundred sixty-five (265) machine ballots.

Inspector's statement says total number of EDRs is 104, actual 105.

From incident log: "voter here #142 to vote, but same/similar name had voted in person – town clerk verified that this voter was not the voter who previously voted in person." "ICX tabulator paper change, voter couldn't finish ballot, paper kept jamming up. (voter #16)"

Provisional ballot returned before deadline.

### **Town of Lincoln-Wards 1-5 –**

Total number of voters four hundred eighty (480). No outstanding provisional ballots. Seventy-eight (78) absentee ballots. Twenty-five (25) EDRs. Ninety-four (94) paper ballots, three hundred eighty-five (385) machine ballots.

One EDR registered and voted in the wrong jurisdiction. Voter #263 and 398 used twice, voter #262 and 397 weren't used.

### **Town of Nashville-Ward 1-3 –**

Total number of voters three hundred thirty-three (333). No outstanding provisional ballots. Twenty-nine (29) absentee ballots. Forty-eight (48) EDRs. Seventy-six (76) paper ballots, two hundred fifty-seven (257) machine ballots.

Voter on page 3, no signature. One EDR registered and voted in the wrong jurisdiction.

### **Town of Nashville-Ward 4-5 –**

Total number of voters two hundred thirty-six (236). No outstanding provisional ballots.

Forty-two (42) absentee ballots. Twenty-two (22) EDRs. **Sixty (60)** paper ballots, one hundred seventy-six (176) machine ballots.

Number of last vote on poll list missing from one of the tally sheets. Inspector's statement says 19 total number of EDRs, actual is 22. Voter #162 and 163 were name changes, they completed new registration forms but signed the poll book instead of the supplemental.

From incident log: "voter voted and pulled card out and reinserted it"

From incident log: "incorrect name on the voting book for voter", these voters need to fill out new registration forms. Incident with unhappy voter, Sheriff's department was asked to go to polling place.
