COMMENTS FROM THE PUBLIC

Rodger Walentowski asked why the RV wording was changed from permits needed after 30 days to 10 days. Mr. Walentowski also asked whose idea it was to require permits. Jeannie explained that there was always a requirement for permits at least for the last 15 years, that this was a decision based on enforcement issues and discussions that were had at previous zoning meetings. Jeannie explained that until now RV's were not allowed to be on private property in certain areas ex. Lake Lucerne, Lake Metonga, and Silver Lake. This new wording allows this to happen. There was concern from the public regarding the fees.

There were no comments from the public regarding the Sanitary Ordinance changes or the UDC ordinance changes.
