PUBLIC COMMENT

Jaron McCullum with the PSC (Public Service Commission) was on remotely and he went through the Local Planning Grant Program. There's \$1.5Million dollars, but it will depend on how many "Opt In" as to what funding will be available for each entity.

- BEAD Local Planning Grant Program (Have Website set-up)
- Counties / Tribes / Regional Areas
- County & Locals need to "Opt In" to receive funding by March 7th, 2023
- Can "Opt In" alone or regionally with others
- Chris Shafer will be getting the "Opt In" letter of intent ready and submitted for Forest County alone.
- Formula Funding but only for PLANNING Phase
- 5 year action plan due the end of August 2023
- High Level Reporting will be required
- Administration of the funds was questioned and will need to be determined
- They have a newsletter on their webpage and this is a good way to stay in touch

UPDATE ON BUG TUSSEL ON PROJECT STATUS:

Mark Dodge explained the project status for Phase #1, Phase #2 and Phase #3 (this is currently being drafted). Mark Dodge explained Phase #3 to the committee and more documentation will be presented to the County Board in March and then a resolution will be presented to the Board to vote on in April. Mark shared that 1100 residents in Forest County are already being served through the progress on Phases #1. Phase #2 will begin in the spring of 2023 and this project is for Middle Mile Fiber to the home. Phase #2 project in conjunction with Phase #1 will lay the groundwork for the Phase #3 project.

Chris Shafer stated that he's been working hand in hand with Bug Tussel and they have done everything that he's asked for. Broadband in one of Forest Counties "Signature" projects that we're applying for grant funding through the RPN (Rural Partnership Network) and Chris was in Washington DC last week to present the grant funding requests on behalf of Forest County. Bug Tussel was instrumental in helping Chris get a plan together (on short notice) for this presentation. It's important to have projects that are "Shovel Ready" when opportunities such as this arise, because time is of the essence. Bringing stable and affordable Broadband to all of Forest County has been a top priority for several years. Now the opportunity has developed to possibly receive some significant grant funding and Forest County was in a position to pull all the figures together for Chris's presentation. Hopefully we'll hear something very soon.
