Gretzinger told the committee there are ongoing issues with Social Services struggling to replace employees. She put together a summary of the problems and requested assistance from the State. They are working diligently with the State and all the State is set up to do is help with suggestions. She also wanted everyone to know that Forest County is not alone in this struggle. Sawyer County has lost all of their social workers and the Human Service Center has pulled a few of our workers and they just got raises. She read the letter to the committee that she is having hand delivered to Governor Evers today. She wants everyone to know so, if God forbid something happens here, everyone knows how the County is struggling. Forest County should not bare this alone because the State puts out all of these services, they need to help.
