Skallerud updated the committee on his communications with the tribes for the social workers. He sent out emails to both tribes and Forest County Potawatomi Community gave him two (2) dates that would work for them, May 2nd and May 4th. He is still waiting on dates from the Sokaogon Chippewa Community.

DISCUSSION WITH S. BONEY ON AMOUNT OF TIME SPENT ON SOCIAL SERVICES AND POSSIBLE ACTION ON PAY ADJUSTMENT FOR THE DURATION OF ADMINISTRATION SUPPORT

Shannon explained to the committee she has been spending a lot more time than initially thought. She started tracking on February 6^{th} and had 32.50 hours already.
