### CONDUCT CANVASS OF THE APRIL 4, 2023, SPRING ELECTION

### Town of Alvin-Ward 1 -

Total number of voters ninety-nine (99). Six (6) EDRs. Six (6) absentee ballots.

No outstanding provisional ballots. Sixty-four (64) paper ballots. Thirty-five (35) machine ballots. Missing absentee log. Machine total shows 38 ballots cast but, Inspector's statement shows 35. Machine tape shows 36 votes including under votes. No incidents logged. Machine totals were all off by 2 votes.

### Town of Argonne-Wards 1-2 –

Total number of voters one hundred twenty-nine (129). One (1) EDR. Sixteen (16) absentee ballots. No outstanding provisional ballots. Eighteen (18) paper ballots. One hundred eleven (111) machine ballots.

## Town of Armstrong Creek-Ward 1 –

Total number of voters one hundred forty-two (142). Four (4) EDRs. Thirteen (13) absentee ballots. No outstanding provisional ballots. Eighty-seven (87) paper ballots. Fifty-three (53) machine ballots.

Inspector's statement shows 140 voters, actual 142. 12 absentee ballots, actual 13. Voter #80 was used twice, once on page 28 and again on page 29 of pollbook. Voter #71 was used twice on the supplemental poll list. Numbers 141 and 142 were not used. Voter #80 was missing from the absentee log.

### Town of Blackwell-Ward 1 -

Total number of voters forty-three (43). One (1) EDR. Five (5) absentee ballots. No outstanding provisional ballots. Five (5) paper ballots. Thirty-eight (38) machine ballots.

#### Town of Caswell-Ward 1 –

Total number of voters forty one (41). Zero (0) EDRs. Three (3) absentee ballots. No outstanding provisional ballots. Ten (10) paper ballots. Thirty (30) machine ballots.

Inspector's statement says seven (7) paper ballots, actual ten (10) according to the incident log.

### Town of Crandon-Wards 1-2 –

Total number of voters two hundred one (201). Seven (7) EDRs. Ten (10) absentee ballots. No outstanding provisional ballots. Fourteen (14) paper ballots. One hundred seventy seven (177) machine ballots.

Inspector's statement had the machine total recorded in the wrong spot, total paper ballots is off by ten (10). Two voters on the supplemental did not have signatures, one did sign the pollbook. One voter on the supplemental did not have a voter number. Voter with a name change signed both the pollbook and supplemental, but there was no new registration form for voter.

### Town of Freedom-Ward 1 -

Total number of voters one hundred fifty-five (155). One (1) EDR. Thirty-four (34) absentee ballots. No outstanding provisional ballots. Sixty-six (66) paper ballots. Eighty-nine (89) machine ballots. Voter #118 on page 16 of the pollbook was marked on the wrong voter's name. Voter on page 23 of the pollbook was missing a voter number, voter number was issued to that same voter on the supplemental poll list.

### Town of Hiles-Ward 1 -

Total number of voters one hundred forty-nine (149). One (1) EDR. Thirty-nine (39) absentee ballots. No outstanding provisional ballots. Eighty-seven (87) paper ballots. Sixty (60) machine ballots.

Inspector's statement is missing total machine ballots. Total paper ballots has 110, but that would equal one hundred seventy (179) total ballots. Largest number of paper votes is eighty-seven (87). No signature for voter #59. Voter #133 has an X for a signature. No signature for voter #41.

#### Town of Laona-Wards 1-4 –

Total number of voters three hundred ninety-six (396). Eleven (11) EDRs. Seventy-two (72) absentee ballots. No outstanding provisional ballots. One hundred thirty-four (134) paper ballots. Two hundred sixty-two (262) machine ballots.

Missing tally sheet, had to call clerk. Inspector's statement has ten (10) EDRs, actual is eleven (11). Voter with an address change signed the pollbook instead of the supplemental poll list.

### Town of Lincoln-Wards 1-5 –

Total number of voters two hundred seventy-eight (278). Four (4) EDRs. Thirty-eight (38) absentee ballots. No outstanding provisional ballots. Fifty (50) paper ballots.

Two hundred twenty-eight (228) machine ballots.

Voter #128 was used twice on page 11 of the pollbook. No signature for voter #206 on page 78. Incident from incident log: "When counting write-ins on machine #1 – it showed 32 write-ins – after going through the tape twice we found thirteen (13) votes for Bostron, two (2) votes for Smith Labine, eleven (11) votes for Brockmeier, four (4) scatterings. Total 30, should be 32."

### Town of Nashville-Ward 1-3 –

Total number of voters one hundred seventy-nine (179). Five (5) EDRs. Eighteen (18) absentee ballots. No outstanding provisional ballots. Thirty-six (36) paper ballots. One hundred forty-three (143) machine ballots.

## Town of Nashville-Ward 4-5 –

Total number of voters one hundred fifty-eight (158). Zero (0) EDRs. Twenty-eight (28) absentee ballots. No outstanding provisional ballots. Thirty-six (36) paper ballots. One hundred twenty-two (122) machine ballots.
