PUBLIC COMMENT

Gretzinger told the committee there are concerns with the Human Service Center and there was a meeting set up to discuss some of the concerns, signed by Paul Millan, where the County Chairs were asked to attend with their Corporation Counsel. The date was set for May 18th without regard to finding out if all were able to attend and our Corporation Counsel is unable to attend. Gretzinger made some calls and now they are giving several dates for everyone to look at first to decide when the meeting will be held so everyone is able to attend.

DISCUSSION AND POSSIBLE ACTION ON ADDITIONAL RADIOS FOR THE JAIL

The committee discussed the additional radios with the Sheriff and the donated money received by the Department. The Sheriff seemed to think there was money available for the radios. The matter will be brought back to Sheriff and Justice.

DISCUSSION AND POSSIBLE ACTION ON APPROVING COMPUTERS FOR THE SHERIFF AND JAIL EMPLOYEES USING LATCF FUNDING; FORWARD TO FULL COUNTY BOARD FOR APPROVAL

Motion by Chaney to approve the computers for the Sheriff and Jail employees using LATCF funding and forward to full county board for approval in resolution form, second by Gretzinger. All present voting (AYE). Motion carried.

DISCUSSION ON 24 FIBER LINES FOR COUNTY USAGE

The committee discussed where these could be located. It was suggested Lukas, call Olsen and ask him if it is dark or lit fiber. After discussing with Olsen, it is dark but, in some cases can be lit for free depending on the location.

UPDATES:

SALES TAX

The Sales tax is up for the current month.

LATCF FUNDS

The LATCF funds will be down to around \$71,000 after the computers and some other items just being designated for usage.

 2023-25 BIENNIAL BUDGET AND POSSIBLE INCREASE TO THE COUNTY SALES TAX INCOME

The state is looking at the budget and giving back some of the excess sales tax revenue to the counties as well as a new shared revenue calculation. This could potentially bring a substantial revenue increase for the county if actually passed.
