- a. IPP Survey Results: Montgomery provided committee with results from survey. Montgomery has been in touch with tribal Emergency Managers to work on the IPP for Forest County.
- b. WiCAMS MOU: Montgomery presented the MOU that the state requires from counties to participate in the WiCAMS program. Motion by Black, second by Miller to forward WiCAMS MOU to Corporation Counsel Payant for review and forward resolution to full county board if needed. All present voting (AYE). Motion carried.
- c. Birch Lake Fire Number Issues: Montgomery has had reports from EMS regarding the difficulty to locate properties on Mill St private sections around Birch Lake. Town of Laona had a meeting and supports the County to correct issues. All committee members agree that naming the two drives something separate from Mill St and also ensuring Fire Numbers are placed at property access points is important. Montgomery will be reaching out to Diane Conner Birch Lake Association President to possibly address the issue.
- d. CPR Hands- Only Class: Red Cross offers Hands only Training for free to any organization. Montgomery spoke with department heads and there was interest in having the class. Motion by Miller, second by Black, to approve Red Cross to hold training and employees to attend. All present voting (AYE). Motion carried.
- e. Disaster Recovery Class: Montgomery has signed up with WEM to host recovery class at Courthouse. Class is designed for local elected officials, Emergency services, government admin, public health, Human services etc. Focus on disaster recovery and what the role of the local community is.
