DISCUSSION AND POSSIBLE APPROVAL USING AGING BUS IN EMERGENCY SITUATIONS

Motion by Black to proceed to create an MOU to include waiver of county liability with the assistance of Stephanie Montgomery, Forest County Emergency Management Director, for use of the Aging Bus in emergency situations, for transportation of At Needs or At-Risk individuals in residential group living situations, second by Van Grinsven. All present voting (AYE). Motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF THE NUTRITION COUNCIL'S BY-LAWS Aging Director Fohrman will add updates on the Nutrition Council to Director's Report. The Commission on Aging Committee will not oversee the Nutrition Council's By-Laws.

DISCUSSION AND APPROVALOF TIMESTAMP TO BEGIN "REQUESTS FOR PROPOSALS" OF CATERING BIDS

Contract with Lynn's Catering will end at the end of December, 2023. Beginning in September, 2023, Aging Director Fohrman will begin the bidding process with ads in the *Forest Republican*, *Pioneer Express*, *Rhinelander Daily News* and *Beacon*.

DISCUSSION AND REVIEW OF THE COA GOALS FROM THE AGING PLAN

Director Fohrman will meet with Nick Musson, GWAAR, regarding the COA goals in the COA Aging Plan. Motion by Sommer to table the Title IIIC Nutrition Program Goal regarding partnering with a local restaurant to develop a "My Meal, My Way" program, second by Abney. All present voting (AYE). Motion carried.

DISCUSSION AND REVIEW OF THE COA'S BUDGET

Director Fohrman reports that she met with CPA Bridget Van Laanen who, upon examining the COA budget, states that financially the COA is doing well with its grants and tax levy. Revenue from Senior Meals is high. The MCO's are paying as expected. Director Fohrman will work with the CPA and the Fiscal Agent to clarify the budget in order to maintain accuracy.

UPDATE ON STOCKBOXES

Director Fohrman reports that 17 people who meet the income requirements to receive Stockboxes have signed up. Director Fohrman would like to have at least fifty people signed up in order for one of the COA drivers to pick them up at one of Hunger Force's closest Hub locations. In order for the Stockboxes to be delivered to Crandon, 120 people need to be signed up.
