Tracy Schumacher states that there are:

- 4 Delinquent Children who are out of home care. One child has been kicked out of a secure detention facility and he needs to be out in the next two weeks. The only other option for this child is Lincoln Hills which is very expensive. Skallerud mentioned the possibility of waving him to an adult depending on age and charges.
- 22 Children in out of home care
- 9 Children on In-home CHIPS
- 2 Children on Out-of-state courtesy services
- 1 Child in a group home
- 5 Open Initial Assessments
- 4 Families on Protective Plans
