Motion by Black to offer the LTE position as Clerk to Stephanie Denton, at the base starting wage for the Clerk position, second by Karl. All present voting (AYE). Motion carried.

### DISCUSSION/ACTION OF DEPARTMENT'S ONGOING CASES

Tracy Schumacher states that there are:

- 36 Children in out of home care
- 7 Children on In-home CHIPS
- 2 Children on Out-of-state courtesy services
- 4 Cases out of home -Juvenile
- 1 guardianship going out of home
- 2 Families in protection plan
- 7 subsidized guardianships

Schumacher is starting to clean up cases in the system, there are 90 cases and 49 of them are old cases that were not closed out from the previous workers. She will work on those first; those take about 1 to 2 hours to complete.

# DISCUSSION/ACTION ON ADDITIONAL AT HOME TRAINING DATES FOR THE DIRECTOR

Tracy explained to the committee that she has a lot of Supervisor training she needs to take that even the former director had not taken and even if she closes her door and asks for no one to enter, it is not happening and she needs to get these trainings completed. She asked other counties how they get these trainings done while at work and was told they do all of theirs from home.

Motion by Gretzinger to approve additional at home training days as needed for Schumacher and forward to Personnel for approval, second by Black. All present voting (AYE). Motion carried.

## DISCUSSION/ACTION ON A COMMUNITY HALLOWEEN EVENT TO BENEFIT THE COMMUNITY CLOSET

Schumacher told the committee she would like to have a Halloween event the day before Halloween to help with fund raising for the community closet. She is thinking of maybe asking all departments to join in on trick-or-treat for the kids.

# DISCUSSION/ACTION ON CHILD PROTECTION PROFESSIONAL STARTING WAGE (T. SHORT) TO FORWARD TO PERSONNEL FOR APPROVAL

Motion by Karl to approve \$22.95 per hour, plus years of service; forward to Personnel for approval, second by Black. All present voting (AYE). Motion carried.

### UPDATE ON SECURE DETENTIONS

The invoice for juvenile secure detentions in Marathon County was for \$104,000 putting the Sheriff Department over budget in the amount of \$195,064, which is not something the department can help.

#### UPDATE ON DELIVERY OF NEW VEHICLE

The Clerk received an email that the car is in production and should be delivered by the end of September.
