Seibold advocated that in the last three months of her covering as interim, there have been no qualified applicants. She stated the wage needs to be increased by approximately \$10,000/yr to receive some applications. The board discussed the information but took No Action

DISCUSSION AND POSSIBLE ACTION: 2024 Health Department Fee's

Seibold presented the 2024 Health Department Fee costs for services and asked to increase flu quadrivalent from \$35 to \$40 and offer high dose flu vaccine \$105. Seibold explained the vast majority

are covered by health insurance which allows for the increases. Radon kits increase from \$8 to \$10. All other fee service costs to stay the same.

Motion by Skallerud second by Goode to except fee schedule. All present voting (AYE). Motion carried.
