DISCUSSION ON CURRENT SOCIAL SERVICES STRUCTURE

Schumacher gave the committee her current Social Services structure and break down of job duties for review or discussion. She explained the structure is working very well and that the last two months they have gone from 13%- 100% completion of in- home visits.

DISCUSSION ON THE NARCAN POLICY; POSSIBLE ACTION

The Narcan Policy was discussed by the committee and Schumacher explained the Emergency Management Director will be training those wanting to be trained.

COMMUNITY CLOSET UPDATE

The Halloween party was a success with around 50 attendees. The department received a lot of donations from clothes to cribs. They are planning a Christmas party as well and the school has agreed to let them use the school's facilities. It is going to be planned for December 11, 2023 from 4-7 p.m.

DISCUSSION ON THE RECOMMENDATION OF DCF TO CONTRACT WITH ANOTHER COUNTY TO CLEAN UP THE KINSHIP/FOSTER CARE LICENSING PARTS OF SACWIS Schumacher explained that since Ashbeck left a couple years ago no one hired has been able to complete the Kinship/Foster Care licensing part of SACWIS. There is a lot that needs to be
