VAMC TOWN HALL

VSO reports that on Wednesday October 10th 2023 he set up and occupied a Veterans Services information booth at Crandon City Hall for a Caregiver Connect Info Fair. VSO states he was present from 10-2 and networked with numerous other local resource vendors.

Caregiver Connect Booth

VSO reports that on Thursday November 2nd 2023 he set up and occupied a Veterans Services information booth at Crandon City Hall for a Caregiver Connect Info Fair. VSO states he was present from 10-2 and networked with numerous other local resource vendors.

WDVA Grant Increase

VSO reports that the annual grant of \$9350 he applies for from the WDVA Wisconsin Department of Veterans Affairs will increase to \$11688. VSO explains that the annual grant assists the county as a salary/ wage offset in regards to budget assistance.

WDVA VORP Mental Health Training

VSO states that on December 15th he set and hosted a mental health resource & training session with the Wisconsin Department of Veteran Affairs Outreach & Recovery Program Coordinator Todd Marks & Wisconsin Department of Veteran Affairs Clinical Coordinator Josh Andreini. VSO states that approximately thirty-eight Forest County Sheriff's Department staff attended. VSO reports that this training provided was presenting about what resources are available for veterans regarding housing/homeless, medical/mental healthcare, nursing care, and the breakdown of the responsibilities of the different levels of Veterans Affairs (county, state, federal). VSO also states that a clinician talked about Trauma Informed Care when speaking to veterans.

Donation Update

VSO reports that he's received another donation from a local veteran (KW) in the amount of \$200. VSO explains that all of these donations are deposited into a non-lapse account that he uses to assist needy veterans, dependents and survivors. VSO states he recently purchased gas cards from Lotters BP & Stone Lake C-Store in the combined amount of \$1000.00 VSO report that the account balance is \$1348.63.

VFW Post Commander Thornton advises of Oscar G Johnson Medical Center Children's Christmas 2023 which is a special project of gathering of gathering funds for Christmas gifts for children of needy veterans from Northern WI and Upper Michigan.
