DISCUSSION ON MOW ENROLLMENT FORMS TO INCLUDE LOCAL EMERGENCY CONTACTS AND PROGRAMS IN WHICH APPLICANT IS ENROLLED

Future MOW enrollment forms will include spaces to provide Health Insurance Provider, Preferred Hospital, and Back-up Service Providers, such as affiliation with MCO's or ADRC, Emergency Transportation, Non-Emergent Transportation, and Health Care Proxy. Ambulance service is a covered service for persons on both Medicare and Medicaid. Persons unaware of their health coverage should contact the ADRC. Generally, in the event of a "non-911" situation, the sheriff's office or local police department should be contacted

DISCUSSION AND POSSIBLE ACTION ON POSTING FOR AN ADDITIONAL BUS DRIVER Motion by Koziol to forward action on posting for an Additional Bus Driver to Personnel, second by Abney.

DIRECTOR'S REPORT

- The Forest County Commission on Aging By-Laws are complete.
- A meal site manager for the Crandon Meal Site has been hired.
- An evidence-based health promotions program, known as Bingocize, will be developed. This
 program includes bingo, exercise and nutritional information. Director Fohrman would like to
 have Bingocize programs take place at the Laona and Wabeno meal sites on Mondays and
 Wednesdays. Two Bingocize kits have been ordered. Raffle prizes will be purchased. Trainers
 are needed.
- 120 Stock Boxes will be distributed to program participants on 12.13.23.
- The Commission on Aging will provide monetary compensation for use of the Crandon and Wabeno meal sites. Currently, the Laona, Armstrong Creek and Alvin meal sites are compensated.
