DISCUSSION ON TRAINING SOCIAL SERVICES EMPLOYEE TO BE A DEC AGENT (T. SHORT); POSSIBLE ACTION

DISCUSSION ON APPROVING EQUIPMENT PURCHASE FOR THE DEPARTMENT TO CONDUCT FORENSIC INTERVIEWS TO BE FORWARDED TO FINANCE FOR APPROVAL; POSSIBLE ACTION

Motion by Goode to approve the purchase of the equipment for the forensic interviews and monitoring of clients as well, per the Naunkca invoice (\$2,454.00); move forward to Finance for funding options and approval, second by Black. All present voting (AYE). Motion carried.

COMMUNITY CLOSET UPDATES

Schumacher reported that the Community Closet is doing very well and almost fully stocked. They are in need of perishable foods and men's clothing and still have \$100.00 for crisis.

HUMAN SERVICE CENTER UPDATES

Schumacher brought a sheet that showed three (3) options for allowable restructures for reorganization. She told the committee that the three (3) directors met with the current employees and that it did not go well. They will not be meeting with them again. There will be a general public meeting on February 9th, 2024 and a Supervisor meeting on January 29th, 2024.
