HSC UPDATES-

a) Oversight Committee meeting

The Oversight Meeting committee met on the 7th and formed the board, Tyler Young is the chair and Ferraro is the Vice Chair. They found out the CLTS program could be paying for some of the kids they are having problems with but, the kids in Forest County never make it off the waiting list and with staff shortages now it will get worse. She will try to make sure going forward the County does not lose any money.

b) Tri-County meeting

She went to a community meeting and there were a lot of angry people complaining about the Counties, not understanding that it is the Human Service Center that is the problem, there also were a lot of people that could not attend so they are going to have another meeting. At that meeting they will try to explain that things will get better, that the Human Service Center is the problem and the counties are trying to fix that. In March Ferraro will start giving updates to the full county board every month.
