Chief Deputy Walrath advised the current cost of Glock Generation 4 pistols is very low. Walrath advised the cost to upgrade the rest of the Sheriff's Office to Gen 4 pistols would be \$4797.00 and resale value of old Gen 3 pistols would be \$4500.00 leaving a total cost to the county of \$297.00 to upgrade to Gen 4 pistols. Walrath requested to use money from the Vehicle Resale account to pay for the pistols and resale money would be placed back in the Vehicle Resale account. Motion by Campbell to approve the purchase, second by Piasini. All present voting (AYE). Motion carried.
