FOLLOW-UP ON HILES , PINE LAKE CULVERT PROJECT INVOICE; POSSIBLE ACTION

The invoice for the design oversight for Hiles was looked into and the Highway Commissioner found a resolution from Hiles stating the design oversight would be 100% paid for by the Town of Hiles

Motion by Skallerud to pay the Hiles design oversight out of Contingency, then have the Clerk invoice the Town of Hiles for re-payment, second by Marvin. All present voting (AYE). Motion carried.

DISCUSSION/ACTION ON REFERENDUM:

1) Retraction of previous motion on press release/updated press release

The committee discussed the previous press release, which Gretzinger was going to sign, but, she thought it should come from the whole committee. The committee talked about the suggestion of the marketing firm to have the release come from an individual rather than from the whole committee, because it is more personal. Lukas told the committee he would sign it on behalf of the whole Finance committee, so, the release was updated to Lukas.

Motion by Chaney to approve signing of the press release by Lukas on behalf of the Finance committee and to approve the marketing firm coming up with a banner for the Visit Forest County electronic sign, if they will allow it, second by Skallerud. All present voting (AYE). Motion carried.

Motion by Gretzinger to approve the colored flyers for the next press release and charge the costs to the advertising budget, second by Chaney. All present voting (AYE). Motion carried.

The Clerk pulled in information from other counties for taxable lands vs. levy.

FEBRUARY 2024 TREASURER INVESTMENT REPORT

Conley was present to go through the report and explain what everything means in the report and where she invests funds to gain interest.

DISCUSSION ON RESERVE ACCOUNTS IN DEPARTMENTS; POSSIBLE ACTION Motion by Chaney to forward the Drug Fund resolution to the County Board for approval with the \$12,436.58 that was deposited to the County Fund from the outside checking account in 2023, second by Skallerud. All present voting (AYE). Motion carried.

DISCUSSION ON BUDGET AMENDMENT FOR DEPARTMENT ACCOUNTS; POSSIBLE ACTION AND FORWARDING TO FULL COUNTY BOARD FOR APPROVAL

There was discussion about budgets and shortfalls when departments ask to carry money over to the next year or put money in for reserve accounts to be used for future use. The practice has been to increase/decrease reserve accounts based on the budget status at the end of the year. If there is additional revenue it is used to offset any budget shortfalls that may occur. Motion by Skallerud to approve the budget amendment and forward to full County Board for approval, second by Marvin. All present voting (AYE). Motion carried.
