All Present voting AYE. Motion Carried

DISCUSSION AND POSSIBLE ACTION ON LAND PURCHASE USING AWARDED ARPA FUNDS. There are two properties of interest one is a 40-acre parcel connecting to existing County Forest Land, the second property is owned by Meteor Timber Company but they have yet return with an answer if they would indeed be interested in selling. The ARPA funds need to be earmarked for a purchase as soon as possible or the County could potentially loose the funds. Committee would like to proceed with the 40-acre parcel and contact land owner to set up meeting.
