Voter #19 was a late registration; not recorded on supplemental.

"Absentee not returned – 4" Inspectors' statement says 39 EDRs, one voter was not on the supplemental or in the poll book. 377 voters were recorded on the poll book and Inspectors' statement, actual is 376. One voter on the supplemental signed page 37of the poll book by old address, name was also recorded on supplemental. One EDR not on the Supplemental poll book. No signatures by the EDR names on the supplemental.
