DISCUSSION/ACTION ON CARRYOUT POLICIES AND PROCEDURES

Motion by Koziol to accept Carryout Policies and Procedures document as presented, with the expectation that criteria for Carrying Out a Congregate Meal will require discussion in 2025, second by Sommer. All present voting (AYE). Motion carried.

DISCUSSION/ACTION ON HDM WAITING LIST POLICIY AND PROCEDURES Currently, the Forest County Nutrition Program does not have a waiting list. Discussion and action on this policy is tabled.

DISCUSSION/ACTION ON TRANSITIONING OF K FOHRMAN'S WORKWEEK TO 4-DAYS CONSISTING OF 10-HOUR DAYS

Motion by Pfeifer to transition Director Fohrman to four 10-hour days and forward to Personnel, second by Koziol. All present voting (AYE). Motion carried.

DIRECTOR'S REPORT

- Fohrman reports that moving her office from the Courthouse to the ADRC building is in progress. Although her computer has been brought over and is working, the phone lines do not work at this time.
- DOT-approved transport of a wheelchair-bound individual living in Madison who was needed to attend court in Forest County was provided by Forest County COA transportation program.
- Tammy Collins, new manager at the Crandon meal site, is doing well; attendance has increased and she has begun a Bingo activity.
- In May of 2024, following the resignation of Tammy Wolfe and the vacancy of a meal site manager at Alvin, the meals served transitioned to a Carry Out format instead of being cooked on site. A new manager was hired with the intention of providing catered meals with congregate dining. However, due to a lack of interest from participants in congregate dining, the meal site manager is currently placing catered food into carry-out containers, and no congregate dining, as anticipated by GWAAR, is taking place. Participants have expressed a desire to return to on-site cooking, but this option is significantly more expensive, costing double the price of catered meals. Director Fohrman will discuss potential options with the manager and diners.
