The Kinship grant for \$24,000 and the DOJ grant for \$25,000. One more grant is still pending. The department will be working to update payments in EWISACWIS because it is now required for them to be set up automatically. Oneida has agreed to give the department one year's worth of ongoing mental health files after the 1<sup>st</sup> of the year. The committee agrees that paper files would be best.

# **OVERVIEW OF DCF 1**

The state is ending child support to counties, so counties will now have to self-collect. The county will be able to set payment amount for services for billing.
