Motion by Lukas to add in pre-pay language to contract, second by Dehart. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE ACTION ON AWARDING BID FOR SWAMP AND SWANSON CREEK BRIDGE REPLACEMENTS

Larson Construction Co. Inc. was the low bidder but we are still short on grant funding. The request for additional funds was put in but it could be a few weeks before we know if we are

approved. Motion by Dehart to approve the bid from Larson Construction Co. Inc. pending approval of additional funding, second by Lukas. All present voting AYE. Motion carried.

#### POSSIBLE APPROVAL OF CONTRACT FOR BOAT LANDING PROJECT

Motion by Miller to approve the contract for the Boat Launch Project, second by Lukas. All present voting AYE. Motion carried.

## ELECTION OF CHAIRMAN AND VICE CHAIRMAN OF THE FORESTRY AND RECREATION COMMITTEE.

Chaney will be resigning from the County Board. County Board will have to appoint the new committee chairman.
